

to offset your carbon footprint with Bosque Sustentable A.C. (BSAC) in Querétaro State, Mexico, reduces CO2 in the atmosphere. The carbon offset program operates under agreement with resident landowners in the Sierra Gorda Biosphere Reserve and transforms carbon footprints into trees. The success of the program is enhanced by on-going programs in community environmental education, skill training, product diversification, and other conservation activities carried out by Grupo Ecológico Sierra Gorda I.A.P. (GESG), an awardwinning grassroots organization in central Mexico.

Sierra Gorda's carbon offset inventory is currently based on a very conservative Intergovernmental Panel on Climate Change (IPCC) estimate. For trustworthy carbon data in situ, we initiated a study with the USDA Forest Service and COLPOS to provide local data to characterize ecosystems by analyzing carbon dioxide captured in naturally regenerated forests through chronosequencing. Research is in progress including periodically monitor 24 permanent plots in oak forests to determine CO<sub>2</sub> increases in biomass.



Since 2014 Queretaro State partnered with GESG to pioneer a sub-national climate change mitigation protocol that partially finances Sierra Gorda Carbon. The tools are to be adapted to five other Mexican States. Good governance, civil society partnerships, transparency and MRV are the keys to its success.

Furthermore, she has received other national and international awards from National Geographic, Rolex Prize for Enterprise, Ashoka Innovators for the Public, Schwab Foundation and others.



The Grupo Ecológico Sierra Gorda, I.A.P. in Mexico is operating a Nationally Appropriate Mitigation Action (NAMA) of "Subnational mitigation actions for the restoration of degraded forests and the implementation of planned grazing." Sierra Gorda's NAMA contributes to the mitigation and adaptation goals of the Nationally Determined Contributions (NDCs) of Mexico under the Paris Agreement. The Sierra Gorda NAMA will build upon the successful state carbon offset mechanism of Querétaro, where the state government has offset emissions of the state vehicle fleet and established a carbon tax on private vehicles registered in the state with proceeds used to partially offset emissions of those vehicles.

# **Local Forest Ranger**

In 2012, Silvestre Cabrera Castillo began receiving carbon compensation payments to ensure the recuperation of the forest's undergrowth on his property. As stipulated, he sold the free grazing cattle that severely degraded the understory and had little financial value.
